In planning and performing our audit of the financial statements of Altmar-Parish-Williamstown Central School District as of and for the year ended June 30, 2023, in accordance with auditing standards generally accepted in the United States of America, we considered Altmar-Parish-Williamstown Central School District's internal control over financial reporting (internal control) as a basis for designing our auditing procedures for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Altmar-Parish-Williamstown Central School District's internal control. Accordingly, we do not express an opinion on the effectiveness of Altmar-Parish-Williamstown Central School District's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses and therefore, there can be no assurance that all deficiencies, significant deficiencies, or material weaknesses have been identified. We did not identify any deficiencies in internal control that we consider to be material weaknesses. However, as discussed below, we identified certain matters involving the internal control and other operational matters that are presented for your consideration. This letter does not affect our report dated October 2, 2023 on the financial statements of the District. We will review the status of these comments during our next audit engagement. Our comments and recommendations, all of which have been discussed with appropriate members of management, are intended to improve the internal control or result in other operating efficiencies. Our comments are summarized as follows:

Current Year Deficiency in Internal Control:

Receipts -

During the course of our examination, we noted three instances in which funds received were not deposited to the bank in timely manner.

To ensure the proper safeguarding and accountability of funds received, we recommend a continued effort be made to deposit all receipts on a timely basis.
